Because Sanitek uses only whole coconut oil, rather than fatty acid extracts, natural glycerin found in the oil is retained. This adds emollient and moisturizing qualities lacking in fatty acid soaps.

The foaming properties and feel of synthetic shampoos may be improved by adding 5-15% coconut oil soap.

Sanitek's Potassium Cocoate contains no dyes, perfumes or fillers.

As with all of Sanitek's products, Potassium Cocoate is subjected to strict quality control tests to insure batch uniformity.
